

- ➤ In 2022, No of Feminicides in Italy: 150 (among them, 103 by a family member or partner/ex partner)
- > 31,5% of Italian women is victim of physical or sexual violence (62,7% by partner/ex partner)



The European Commission deemed necessary to address the issue of gender-based violence in the academic field, to implement inclusion policies and intersections with other diversities and other potential reasons for discrimination, such as ethnicity, disability, or sexual orientation."






#### Legal Ground : b) The Istanbul Convention

#### > Art. 14: Education

Article 14 of the Istanbul Convention requires that programmes at all levels of education (primary, secondary and tertiary) promote the values of gender equality, mutual respect in interpersonal relationships and non-violence and that they enlighten learners about the various forms of violence covered by the scope of the convention





### Italy | Round Baseline Evaluation Round GREVIO/Inf(2019)18 | Publication date: 13/01/2020

99. Bearing in mind the need to follow an integrated approach in mainstreaming gender in the education system, in line with Recommendation CM/Rec(2007) I3 of the Committee of Ministers to member states on gender mainstreaming in education, GREVIO strongly encourages the Italian authorities to:

a. pursue their efforts to mainstream gender equality and information about gender-based violence in all its forms, including forced marriage and female genital mutilation, and the topics covered by Article I4 of the Istanbul Convention in the education system, by ensuring the wide dissemination of the national guidelines on the education of respect in all schools and vocational establishments throughout the country and by promoting obligatory initial and in-service training of teachers and all education staff on these topics; b. develop a set of indicators allowing for the measurement of pupils' skills and competences on the topics mentioned in Article I4 of the Istanbul Convention and in relation to all forms of gender-based violence against women; c. finalise and implement the national guidelines for education on affectivity, sexuality and reproductive health in schools, as an important means to introduce pupils to the topics of the right to physical integrity and the definition of sexual violence given in Article 36 of the Istanbul Convention.







### Program: interdisciplinarity (i)

#### Course syllabus

The course programme includes an in-depth examination of the issues underlying the effective guarantee and implementation of the principle of gender equality in the various fields of interest:

- Violence against women and gender inequality. From the lack of constitutional implementation to inclusion strategies
- From a criminal law and honor of the family-centered perspective to the centrality of the consent (because punishing is not enough)
- The forms of violence: sexual, psychological, physical, economic
- The cycle of violence
- Risk assessment and prevention of gender-based violence

### Program: interdisciplinarity (ii)

- Classification of the profiles and methods of recovery of the perpetrator of the violence, with attention to criminological perspective
- Gender-based violence in the language of the media: stereotypes and normalization of the emergency
- Victims twice (secundary victimization): women who suffer violence in the process and in the relationship with the anti-violence network.
- Violence against women with disabilities
- Gender-based violence, a phenomenon without borders: the role of supranational law





# 3. Public engagement: the university go to school

# a) The project "Gender-based violence, law, and society: educating to prevent"

Conceived and curated by Prof. Irene Pellizzone in collaboration with the Interuniversity Research Center for Gender Cultures, was funded and supported by the Public Engagement Office.

This project is part of UniMi Connect, an annual program of initiatives aimed at promoting and enhancing the cultural and scientific contributions of the University of Milan.

The project is structured as an educational path targeted at students and teachers of middle and high schools, with the goal of providing them with tools to recognize and prevent phenomena of gender-based violence and the lack of equal opportunities. The project's main activities include:

- Workshops: These sessions in schools were designed to address and dismantle gender stereotypes through group exercises and discussions. For example, students were divided into groups to identify and discuss traits associated with the "real man" and the "real woman."
- Role-playing: A second workshop activity involved a role-playing game where students took on the roles of lawyers for the defendant and the victim, as well as judges, in hypothetical cases of sexual violence (including those where consent was invalidated by drugs or alcohol), group sexual violence, stalking, and revenge porn. These scenarios also addressed the issue of victim response, exploring the dynamics of nonreaction during and after the violence, such as in the case of a victim accepting a ride from the aggressor.
- Finally, the project concludes with a final feedback event where the results and reflections from the activities are shared.


### 5247 answers

• In percentage terms, the most at-risk category is that which includes doctoral candidates, interns, research fellows, RTDA, and RTDB (ASS&DOTT&SPEC&RTDA&B). It reports the highest percentages of reports regarding: sexual violence (or attempted sexual violence) outside university premises involving a person known at the university (D7), and sexual violence and attempted sexual violence through contact with intimate parts both inside and outside the university (D2, D4, D8, and D10).

### Ad alta voce/Out Loud (iii)


