Directive Gender-based violence (digital (sexual) violence):

Directive (EU) 2024/1385

Adopted 14 may 2024/ Transposition 14 june 2027

Victim's rights directive: Directive (EU) 2012/29

III. Directive and FJC ?

A. Article 40: multi-agency approach

Member States shall put in place appropriate mechanisms, with due regard to national law or practice, to ensure the effective coordination of and effective cooperation among relevant authorities, agencies and bodies, including ombudsmen, local and regional authorities, law enforcement, the judicial authorities, without prejudice to judicial independence, support services, in particular women's specialist support services, as well as non-governmental organizations, social services, including child protection or welfare authorities, education and healthcare providers, the social partners, without prejudice to their autonomy, and other relevant organizations and entities, in protecting victims from violence against women and domestic violence and in supporting them.
